RESOLUTION NO.084, SERIES OF 2016

AUTHORIZING THE HONORABLE MAYOR JOSE ANTONIO T. FELICIANO TO DONATE 400 SQUARE METERS PORTION OF THE DAPDAP PUBLIC CEMETERY LOT TO THE BUREAU OF FIRE PROTECTION (BFP) TO SERVE AS SITE OF MUNICIPAL FIRE STATION, AMENDING FOR THE PURPOSE SB RESOLUTIONS NO. 291 AND 294 BOTH SERIES OF 2015

WHEREAS, the donation of lot to the Bureau of Fire to pave the way for the construction of a fire station was already authorized in 2015 thru SB Resolutions No. 291 and 294 wherein a 400 square meter portion of lot of Bamban Industrial Complex was the proposed site;

WHEREAS, a recent shift in the development plans of the present administration necessitated the change in the location of the proposed fire station to what is considered a better and more strategic site, that is at the DapDap Resettlement area;

WHEREAS, the DapDap Resettlement Area is owned by and is under the jurisdiction of the Municipal Government by virtue of a Deed of Transfer and Acceptance (DOTA) executed by and between the Municipality and the National Housing Authority dated February 13, 2015;

NOW THEREFORE, on motion of Councilor Ernesto Go, unanimously seconded:

BE IT RESOLVED, to authorize the Honorable Mayor Jose Antonio T. Feliciano to donate Four Hundred Square Meters (400 sq. m) portion of the DapDap Public Cemetery lot to the Bureau of Fire Protection to serve as site for the proposed Municipal Fire station, amending for the purpose SB Resolutions No. 291 and 294, both series of 2015.

RESOLVED FURTHER, let copies of this resolution be forwarded to the Honorable Mayor Jose Antonio T. Feliciano and the Bureau of Fire Protection thru F/Dir. Bobby V. Baruelo, Chief, Bureau of Fire Protection, F/CSUPT Aloveel V.
