RESOLUTION NO. 219, SERIES OF 2021

A RESOLUTION EXTENDING THE DEADLINE FOR PAYMENT OF TAXES AND RENEWAL OF BUSINESS PERMITS FOR ALL LOCAL BUSINESS ESTABLISHMENTS AND TRANSPORT OPERATORS IN THE MUNICIPALITY FROM JANUARY 20, 2021 TO FEBRUARY 24, 2021

WHEREAS, Mr. Carlito Policarpio, Municipal Administrator, on January 13, 2021 wrote the Sangguniang Bayan to request extension of deadline for payment of local taxes and renewal of business permits, in consideration of the prevailing COVID-19 pandemic that forced many businesses to shutdown or suffer in sales, caused high unemployment or simply made tax payment transactions of the public a little difficult due to numerous health protocols to observe;

WHEREAS, based on the Local Government Code of 1991 and the Revised Revenue Code of the Municipality, deadline for the payment /renewal of business permits and other taxes is on the 20th of January whereby no penalty or surcharge is imposed;

WHEREAS, the Sangguniang Bayan is cognizant of the difficult economic situation faced by many local taxpayers and would want to ease it by giving them enough time to settle their obligations;

NOW THEREFORE, on unanimous motion of the Body:

BE IT RESOLVED, that acting favorably in the interest of local taxpayers, the Sangguniang Bayan hereby extends the deadline for the payment of local taxes due and renewal of business permits for all local business establishments and transport operators in the Municipality from January 20, 2021 to February 24, 2021.

RESOLVED FURTHER, let copies of this resolution be furnished Mayor Jose Antonio T. Feliciano, Ms. Agnes M Lacanlale, Municipal Treasurer, all punong barangays in this Municipality and others concerned, for their information.
