RESOLUTION NO.222, SERIES OF 2021

A RESOLUTION REITERATING TO THE HONORABLE GOVERNOR SUSAN YAP OUR STANDING REQUEST FOR THE TURN-OVER OF THE ANUPUL PRODUCTIVITY BUILDING TO THE MUNICIPAL GOVERNMENT OF BAMBAN UPON EXPIRATION OF THE LEASE CONTRACT WITH LIMOTEX, INC THIS YEAR (2021)

WHEREAS, in 2015 the Sangguniang Bayan made a formal request to then Governor Victor A. Yap via SB Resolution No. 224 dated June 1, 2015 to turn-over the ownership and administration of the Anupul Productivity Building to the Municipal Government of Bamban, citing therein the reasons;

WHEREAS, the request was unfortunately denied, with the then lessor of the building (Limotex, Inc.) getting a renewed lease contract with the Provincial Government of Tarlac for another 5 years;

WHEREAS, the need for additional office spaces and venues for numerous activities required by the government has become even more pronounced in recent years and the Municipal Government has no other available option due to financial constraints but to request for the turnover of the said building;

NOW THEREFORE, on unanimous motion of the Body:

BE IT RESOLVED, to respectfully request the Honorable Governor Susan Yap to turn-over to the Municipal Government of Bamban the ownership and administration of the Anupul Productivity Building upon expiration of the lease contract with Limotex Inc., this year (2021)

RESOLVED FURTHER, let copies of this resolution, together with SB Resolution No. 224, Series of 2015 be forwarded to Hon. Governor Susan A. Yap for her information and positive response, and be furnished Mayor Jose Antonio T. Feliciano for his information.
