**APPROVING THE REALIGNMENT OF ONE MILLION THREE HUNDRED FORTY FOUR THOUSAND PESOS (PHP1,344,000.00) IN THE CURRENT MUNICIPAL BUDGET TO BE UTILIZED FOR COVID-19 RELATED PROGRAMS, PROJECTS, ACTIVITIES AND EXPENSES**

WHEREAS, in his letter to the Sangguniang Bayan dated 19 January 2021, Mayor Jose Antonio Feliciano requests for the realignment of Php1,344,000.00 taken or sourced from the appropriations for purchase of ambulance/rescue truck/rolling store truck, to be utilized instead for programs, projects, activities and expenses related to COVID-19;

WHEREAS, this Body is convinced that the realignment is necessary for the LGU to be able to sustain its efforts to combat COVID-19 that include provision for food, transportation, fuel assistance to frontliners, medical personnel, PUMS/PUIs and other expenses involved in the operation of temporary quarantine facility;

WHEREAS, the said realignment of fund is supported by a Statement of Unexpended Fund/Statement of Realignment dated January 18, 2021;

NOW THEREFORE, on unanimous motion of the Body:

BE IT RESOLVED, to approve the realignment of One Million Three Hundred Forty Four Thousand Pesos (Php1,344,000.00) in the current municipal budget to be utilized for COVID-19 related programs, projects, activities and expenses.

RESOLVED FURTHER, let copies of this resolution be forwarded to Mayor Jose Antonio T. Feliciano and be furnished Ms. Rowena T. Manalese, Municipal Budget Officer, Ms. Rosario Campo Admin Officer V at Accounting Office, and others concerned, for their information and appropriate action.
