RESOLUTION NO. 229, SERIES OF 2021

REQUESTING THE DEPARTMENT OF AGRARIAN REFORM (DAR) –CAPAS TO DONATE TO THE MUNICIPAL GOVERNMENT OF BAMBAN A 6,426 SQ. METER PARCEL OF LAND LOCATED AT SITIO PAG-ASA IN BARANGAY ANUPUL TO SERVE AS SITE OF THE PROPOSED RURAL HEALTH UNIT 3

WHEREAS, with the continuously growing population of the Municipality, it becomes imperative for the Municipal Government to establish additional health centers (or rural health units) in order to provide the public easy access to health services extended by the government;

WHEREAS, one area needing a separate rural health unit is the densely populated Anupul for which the Municipal Government has already committed for the facility's establishment, with the assistance of DOH;

WHEREAS, the Municipal Government has identified an ideal site in Sitio Pag-asa that is under the administration of the Department of Agrarian Reform (DAR) which measures 6,426 square meters, and described as Lot 90-A-6 Ccs-036902-000466;

NOW THEREFORE, on joint motion of Councilor Jayson S. Galang and Councilor Fortunato V. Mejia:

BE IT RESOLVED, to request the Department of Agrarian Reform (DAR) Capas, Tarlac to donate to the Municipal Government of Bamban a 6,426 square meters parcel of land located at Sitio Pag-Asa, in Barangay Anupul, which is described as Lot 90-A -6 Ccs-036902-000466, to serve as site of the proposed Rural Health Unit 3.
