FELICIANO TO MAKE AN OFFER TO BUY A APPROXIMATELY TWO THOUSAND (2,000) SQUARE METERS UNDIVIDED PORTION OF THE PROPERTY OF HEIRS OF VIRGINIA CADIANG, LOCATED ALONG MCARTHUR HIGHWAY IN BARANGAY ANUPUL, THIS MUNICIPALITY TO ENABLE EXPANSION AND IMPROVEMENT OF THE PRESENT SITE OF BAMBAN MUNICIPAL HALL**

RESOLVED, as it is hereby resolved, that in reiteration of the intent of the previous Sangguniang Bayan expressed under its Resolution No. 213, series of 2017, this Body hereby authorizes anew the Honorable Mayor Jose Antonio T. Feliciano to make an offer to buy a approximately Two Thousand **2,000 square meters** undivided portion of the property in the name of Heirs of Virginia Cadiang described as Lot 4, Psd -03-29855 (OLT) covered by TCT No. 50168 with EP No.00802982, located along McArthur highway, Barangay Anupul, this Municipality, subject to market valuation as determined by the Tarlac Provincial Appraisal Committee (PAC) in its Resolution No. 11-2017, dated September 27, 2017.

RESOLVED FURTHER, to request that the Sangguniang Bayan be consistently informed of any action taken on this regard.
