**A RESOLUTION ENDORSING TO THE DEPARTMENT OF TOURISM (DOT) AND TOURISM
INFRASTRUCTURE AND ENTERPRISE ZONE AUTHORITY (TIEZA) FOR FUNDING
THE CONSTRUCTION OF SITIO SAN MARTIN TO SITIO BUROG ROAD
LEADING TO TOURIST SITES IN THE MUNICIPALITY OF BAMBAN**

WHEREAS, the Municipality of Bamban boasts of numerous, although still undeveloped potential tourist sites such as water falls, located in mountainous areas that are a haven for adventurist travelers;

WHEREAS, the local Tourism Council sees the need to initially develop and make accessible the roads leading to these sites in Bamban;

WHEREAS, one of these access roads is Sitio San Martin to Sitio Burog with an approximate length of 2,000 linear meters, that needs around P27 Million funding based on the program of works prepared by the Municipal Engineer;

NOW THEREFORE, on unanimous motion of the Body:

BE IT RESOLVED, that the Sangguniang Bayan hereby endorses to the Department of Tourism and TIEZA for funding, the construction of Sitio San Martin to Sitio Burog in the Municipality of Bamban that leads to potential tourist sites of waterfalls, mountain treks, resort and picnic areas.
