**A RESOLUTION REQUESTING THE PHILIPPINE AMUSEMENT & GAMING CORPORATION (PAGCOR) THRU MS. ANDREA DOMINGO, CHAIRMAN AND CEO, TO DONATE A MULTI-PURPOSE BUILDING/EVACUATION CENTER TO THE MUNICIPALITY OF BAMBAN**

WHEREAS, the Municipality of Bamban is a second class municipality with a population of around 69,466 based on 2015 census;

WHEREAS, although struggling with its meager annual budget, it strives to put up all the necessary facilities that the national government requires such as an evacuation center for disaster management and preparedness;

WHEREAS, this Body is aware that the Philippine Amusement and Gaming Corporation (PAGCOR) extends assistance to local government units by way of funding the construction of these facilities, and the Municipal Government of Bamban desires to avail of the corporation's program, in order to improve further its disaster preparedness and response with the ultimate aim of preventing loss of lives and maintaining human dignity in times of calamities;

NOW THEREFORE, on motion of Councilor Fortunato V. Mejia, unanimously seconded:

BE IT RESOLVED, to request the Philippine Amusement & Gaming Corporation, thru Ms. Andrea Domingo, Chairman & CEO, and Mr. Redentor Rivera, Gen. Manager II, Casino Filipino Angeles, to grant funding assistance to the Municipality of Bamban for the construction of a multi-purpose building/evacuation center.
