RESOLUTION NO. 236, SERIES OF 2021

A RESOLUTION APPROVING THE REALIGNMENT OF TWO MILLION SEVEN HUNDRED FIFTY TWO THOUSAND PESOS (Php 2,752,000.00) IN THE CURRENT MUNICIPAL BUDGET FOR THE IMPLEMENTATION OF 2ND TRANCHE SALARY INCREASE OF THE MODIFIED SALARY SCHEDULE FOR LOCAL GOVERNMENT PERSONNEL AND GRANT OF TERMINAL/MONETIZATION LEAVE BENEFITS TO CERTAIN EMPLOYEES

WHEREAS, Mayor Jose Antonio Feliciano in his letter to the Sangguniang Bayan dated February 9, 2021 requests for the approval of realignment of funds in the total amount of P2,752,000.00 for the implementation of the 2nd tranche salary increase of Municipal government personnel and also for the grant of terminal leave benefits of officials/personnel;

WHEREAS, the said salary increase is based on DBM LBC No. 132 dated January 6, 2021 or the Implementation of 2nd Tranche of the Modified Salary Schedule for Local Government Personnel pursuant to RA 11466;

WHEREAS, as gleaned from the Statement of Fund for Realignment dated February 8, 2021 copy of which is attached, the funds are taken from the reserve funds from various offices that are intended for the 2nd tranche salary increase;

NOW THEREFORE, on motion of Councilor Ernesto Salting, unanimously seconded:

BE IT RESOLVED, as it is hereby resolved, to approve the realignment of Two Million Seven Hundred Fifty Two Thousand Pesos (Php2,752,000.00) in the current Municipal Budget for the implementation of 2nd Tranche Salary Increase of the Modified Salary Schedule for local government personnel.
