RESOLUTION NO. 237, SERIES OF 2021

A RESOLUTION ADOPTING THE RESPECTIVE BARANGAY SK DEVELOPMENT PLANS (CBYDP 2020-2022, ABYIP 2021 AND 10% BYDF 2021 & 2020 BYDF (UNEXPENDED BALANCE) OF BARANGAYS SAN ROQUE, SAN NICOLAS, ANUPUL, DELA CRUZ AND LOURDES

WHEREAS, the Sangguniang Kabataan (SK) Councils of Barangays San Roque, San Nicolas, Anupul, Dela Cruz and Lourdes have submitted to the Sangguniang Bayan for review their respective Comprehensive Barangay Youth Development Plan (CBYDP 2020-2022), Annual Barangay Youth Investment Program (ABYIP) 2021, 10% Annual Brgy. Youth Development Fund (ABYDF) 2021, and Unexpended ABYDF Balance of 2020, all approved via their respective SK council resolutions;

WHEREAS, said plans have been reviewed by the Committee on Sports & Youth Development with the assistance of the Municipal Budget Officer and found the same to be necessary and consistent with the guidelines set forth under DBM-DILG-NYC Joint Circular No. 2019-001 or the Guidelines on the Appropriation, Release, Planning and Budgeting Process for the SK Funds;

NOW THEREFORE, on motion of Councilor Nikko T. Balilo, unanimously seconded:
