FELICIANO TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH DEPARTMENT OF SCIENCE AND TECHNOLOGY (DOST) REGION III FOR THE ESTABLISHMENT OF BAMBOO NURSERY AND PROVISION OF COMMUNAL WATER FILTRATION SYSTEM UNDER THE 2021 DOST-III REGIONAL GRANTS-IN-AID PROGRAM
