RESOLUTION NO. 261, SERIES OF 2021

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR JOSE ANTONIO T. FELICIANO TO SIGN A DEED OF DONATION FOR THE ACCEPTANCE OF ONE (1) SHREDDER AND ONE (1) COMPOSTER FROM THE DENR-EMB

WHEREAS, the Department of Environment and Natural Resources - Environmental Management Bureau (DENR-EMB) in pursuance of its mandate to assist local government units in the effective implementation of solid waste management plans and programs freely conveys by way of donation biodegradable waste shredders and composters;

WHEREAS, the Municipality of Bamban is one of the recipients of said equipment;

WHEREAS, the Deed of Donation formalizing the transfer of said equipment has been reviewed by this Body and found the same to be necessary;

NOW THEREFORE, on unanimous motion of the Body:

BE IT RESOLVED, to authorize the Honorable Mayor Jose Antonio T. Feliciano to sign the Deed of Donation for the acceptance of the following solid waste management equipment from DENR-EMB, to wit:

- One (1) unit biodegradable waste shredder with minimum capacity of 250 kg, 12 HP diesel engine, with electric and manual start, composed of shredding chamber and shredder blades; and
- One (1) unit composter with capacity of 1,000kg per batch for 24 hr. operation, 5HP electric motor 220v, 60hz, single phase with speed reducer 1:10 type 120
