RESOLUTION NO. 265, SERIES OF 2021

A RESOLUTION APPROVING THE REALIGNMENT OF TWELVE MILLION PESOS (PHP12,000,000.00) IN THE CURRENT MUNICIPAL BUDGET TO BE UTILIZED FOR FOOD ASSISTANCE TO QUARANTINED FAMILIES, VARIOUS MEDICINES AND MEDICAL SUPPLIES FOR COVID-19 AND REHABILITATION OF ROAD AT SITIO GUMAIN, BARANGAY LOURDES, THIS MUNICIPALITY

WHEREAS, presented for consideration of the Body is the letter dated March 23, 2021 of Mayor Jose Antonio T. Feliciano requesting the Sangguniang Bayan to realign P12,000,000.00 in the current Municipal Budget to be used for relief goods, medicines and various medical supplies for COVID-19 and rehabilitation of Sitio Gumain road in Barangay Lourdes;

WHEREAS, the request is supported by a Statement of Fund for Realignment dated March 23, 2021, which indicates that the funds being realigned are from 20% EDF supposedly intended for Construction/Improvement/Rehabilitation of Multi-Purpose Building/Civic/Evacuation Center;

WHEREAS, the request for fund realignment was discussed during the Committee hearing wherein it was particularly straightened out that the "relief goods" to be procured are actually food assistance to be extended to quarantined families or for distribution only in case of localized (sitio or barangay) lockdowns, and are not relief goods for mass distribution;

NOW THEREFORE, on motion of Councilor Ernesto M. Salting, unanimously seconded:

BE IT RESOLVED, to approve the realignment of Twelve Million Pesos (Php12,000,000.00) in the current Municipal Budget to be utilized as follows:

P 5,000,000.00 – Food assistance to quarantined families
P 5,000,000.00 – Purchase of COVID`19 medicines, supplies & equipment
P 2,000,000,00 – Rehabilitation of road at So. Gumain, Brgy. Lourdes

RESOLVED FURTHER, let copies of this resolution be furnished Mayor Jose Antonio T. Feliciano, Ms. Rowena T. Manalese, Municipal Budget Officer, Dr. Rommel Leal, Municipal Health Officer, all punong barangays of this Municipality, and others concerned, for their information.
