RESOLUTION NO. 267, SERIES OF 2021

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR JOSE ANTONIO T. FELICIANO TO NEGOTIATE WITH THE LANDBANK OF THE PHILIPPINES-CAPAS BRANCH FOR A MAXIMUM OF P150 MILLION LOAN FOR PROCUREMENT OF COVID-19 VACCINES

WHEREAS, Mayor Jose Antonio Feliciano in his letter dated January 25, 2021 requests the Sangguniang Bayan to authorize or approve the securing of loan with Landbank of the Philippines for the procurement of COVID-19 vaccines;

WHEREAS, said matter was taken up during an *en banc* meeting on February 22, 2021 and April 12, 2021 which were conducted with the Municipal Health Officer/Rural Health Physician of the Municipality and the Municipal Budget Officer in attendance;

WHEREAS, this Body is convinced that contracting a bank loan is imperative for the Municipal Government in view of its very limited budget and a scarce supply of vaccine from the Provincial Government;

NOW THEREFORE, on motion of Councilor Ernesto Salting, unanimously seconded:

BE IT RESOLVED, as it is hereby resolved, to authorize the Honorable Mayor Jose Antonio Feliciano to negotiate with the Landbank of the Philippines-Capas Branch for a maximum of P150Million loan for procurement of Covid-19 vaccines;

RESOLVED FURTHER, let copies of this resolution be forwarded to Mayor Jose Antonio T. Feliciano and be furnished Ms. Zenaida B. Gonzales, Manager of Landbank-Capas branch, Ms. Agnes Lacanlale, Municipal Treasurer, Ms. Rowena Manalese, Municipal Budget Officer, for their information and appropriate action, and be furnished Ms. Rosario Campo, OIC Municipal Accountant, all punong barangays and others concerned, for their information.
