RESOLUTION NO. 269, SERIES OF 2021

APPROVING THE ACCREDITATION OF PARAGON ELITE CHARITY PHILIPPINES, INC AS A CIVIL SOCIETY ORGANIZATION IN THE MUNICIPALITY OF BAMBAN

WHEREAS, Article 62, Rule XIII of the IRR of RA 7160 (Local Government Code of 1991) mandates local government units to promote the establishment and operation of peoples organizations, non-governmental organizations and the private sector, to make them active partners in the pursuit of local autonomy and to directly involve them in the plans, programs, projects or activities of the local government unit, such as, but not limited to membership in local special bodies(LSBs) and involvement in the delivery of basic services and facilities;

WHEREAS, this Sanggunian believes that in forming a sustainable foundation of good governance and participatory governance, it is important to develop and strengthen partnerships with civil society organizations in order to empower citizens to articulate their needs as they participate in the program planning, decision-making process, implementation and monitoring at the local level;

WHEREAS, the application for accreditation of Paragon Elite Charity Philippines, Inc. – Bamban Chapter was reviewed and found to be compliant with the documentary requirements and other criteria set forth according to law and the reviewing committee;

NOW THEREFORE, on motion of Councilor Ariel R. Alimurong, unanimously seconded:

BE IT RESOLVED, as it is hereby resolved, that the Sangguniang Bayan hereby approves the accreditation of PARAGON ELITE CHARITY PHILIPPINES, INC.–BAMBAN CHAPTER as Civil Society Organization in the Municipality.
