RESOLUTION NO. 271, SERIES OF 2021

**A RESOLUTION REQUESTING THE MANAGEMENT OF PORTLAND-TARLAC/POWERTRAC, INC.
TO RECONSIDER AND EXTEND FURTHER UNTIL JUNE 30, 2021, THE PERMISSION GRANTED TO
FARMERS/MEMBERS OF BARANGAY SAN ROQUE FARMERS ASSOCIATION TO USE
TEMPORARILY AS ACCESS ROAD A PORTION OF ITS PROPERTY IN SITIO
BUSLO, BARANGAY SAN ROQUE, THIS MUNICIPALITY, PENDING THE
REHABILITATION OF AN ALTERNATIVE EARTH ROAD**

WHEREAS, in a gesture of compassion to farmers/members of Barangay San Roque Farmers Association, the management of Portland-Tarlac/Powertrac, Inc., allowed the farmers to continuously access a portion of its property that conveniently leads to and from their farm lots at Sitio Buslo until April 17, 2021, which now already expired;

WHEREAS, the Municipal Government is doing its best to respond to the plea of farmers to open and rehabilitate an alternate access road but this will take time or around 2-3 months as the project is still subject to government bidding process;

WHEREAS, the Sangguniang Bayan fully understand the concern for security of the private company but also take into consideration the plight of the affected farmers who have no other recourse in the meantime, but to use the afore mentioned private property of Portland-Tarlac/ Powertrac, Inc. in order to attend to their farm lots at Sitio Buslo which serve as their main source of livelihood;

NOW THEREFORE, on unanimous motion of the Body:

BE IT RESOLVED, that, for humanitarian consideration the Sangguniang Bayan hereby requests for the second and last time, the management of Portland-Tarlac/Powertrac Inc., to extend until **June 30, 2021** the permission granted to the local farmers/members of the Barangay San Roque Farmers Association to continuously use as "access road" a portion of its property in Barangay San Roque, to enable them to attend to their farm lots at Sitio Buslo, Barangay San Roque.

RESOLVED FURTHER, let copies of this resolution be forwarded to Mr. Nicholas Joel Yanzon, General Manager of Portland-Tarlac/Powertrac, Inc. for his information and consideration and be furnished Mayor Jose Antonio T. Feliciano, Engr. Jose L. Vital, Mr. Jesus Gomez, president of Barangay San Roque Farmers Association and others concerned, for their information and positive response.
