**A RESOLUTION EXTENDING CONDOLENCES AND SYMPATHY TO THE BEREAVED FAMILY
OF THE LATE ALEXANDER M. VERGARA, FORMER SB MEMBER OF BAMBAN AND HIS
SPOUSE DR. ANABELLE BASILIO-VERGARA**

WHEREAS, the Sangguniang Bayan received with extreme sadness the news on the passing away of former SB member, Alexander M. Vergara who died on the evening of April 23, 2021, only hours after his spouse Dr. Anabelle Basilio-Vergara succumbed to a lingering illness;

WHEREAS, the late councilor served as member of the first Sangguniang Bayan (under the new Local Government Code of 1991 set-up) - for two consecutive terms - from 1992-1995 and 1995-1998, at a time when the Municipality of Bamban was in its most darkest and desperate time, reeling from the catastrophic eruption of Mt Pinatubo;

WHEREAS, there has been an outpouring of expression of grief and sense of loss from mostly Bambanenses who had been "*Konsya!*" Alex's childhood friends, classmates, or colleagues in church organizations, fondly remembering the fellow's genuine kindness, natural charm and humor;

WHEREAS, his colleagues in the Municipal Government will dearly remember in him a person who was compassionate and a dedicated public servant who, in his time as member of the local legislative body, stood well to the challenges of rebuilding a calamity-ravaged Bamban;

WHEREAS, this Body understand the deep sorrow and loss that the family must have been feeling with the demise of the beloved couple;

NOW THEREFORE, on unanimous motion of the Body:

BE IT RESOLVED, that the Sangguniang Bayan hereby extends its sincere condolences and sympathy to the bereaved family of the late Alexander M. Vergara and spouse Dr. Anabelle Basilio-Vergara and hereby joins their surviving family, their friends and relatives in praying for the eternal repose of their souls.
