RESOLUTION NO. 275, SERIES OF 2021

**RESOLUTION APPROVING THE REALIGNMENT OF TWELVE MILLION PESOS
(PHP12,000,000.00) IN THE CURRENT MUNICIPAL BUDGET (UNEXPENDED 20% EDF) TO BE
UTILIZED FOR EXPENSES FOR THE LEASE/RENTAL OF BUILDING TO ACCOMMODATE
COVID-19 PATIENTS/PUMs/PUIs, PROCUREMENT OF MEDICAL EQUIPMENT AND
SUPPLIES AND FOOD ASSISTANCE TO FRONTLINERS/MEDICAL
PERSONNEL, COVID-19 PATIENTS/PUMs/PUIs**

WHEREAS, presented for consideration of the Body is the letter dated April 26, 2021 of Mayor Jose Antonio T. Feliciano requesting the Sangguniang Bayan to realign Twelve Million Pesos (P12,000,000.00) in the current Municipal Budget to be used for: expenses for the lease/rental of space or building to accommodate COVID-19 patients/PUMs/PUIs; procurement of medical equipment and medical supplies; and food assistance to frontliners/medical personnel, COVID-19 patients, PUMs/PUIs;

WHEREAS, the request is supported by a Statement of Fund for Realignment dated April 26, 2021 which indicates that the funds being realigned are from 20% EDF supposedly intended for Tourism Development Projects (lot purchase, site development, construction of drag strip/race track and firing range facilities);

WHEREAS, the request for fund realignment was considered as an urgent matter that need not be referred to and tackled in committee level meetings, and instead be approved promptly;

NOW THEREFORE, on motion of Councilor Fortunato V. Mejia, unanimously seconded:

BE IT RESOLVED, to approve the realignment of Twelve Million Pesos (Php12,000,000.00) in the current Municipal Budget to be utilized as follows:

P7,200,000.00 – lease/rental of space/building for COVID-19 patients/PUMs/PUIs
P2,800,000.00 – Procurement of medical equipment and medical supplies
P2,000,000.00 – Food assistance to frontliners/medical personnel, COVID-19 patients/
PUMs
